

North Liberty Town Council Minutes – December 30, 2014

The year end meeting of the North Liberty Town Council was held at the North Liberty Community Building. Gerry Brown called the meeting to order at 5:20 P.M.

Will Groves, Jr. and Richard Warner Council Members, Town Marshal Michael Sawdon and Vicki Kitchen Clerk-Treasurer were in attendance. Brett Voreis and Matthew Peterson Council Members, Utilities Manager Skip Davidson, and Attorney Peddycord were not in attendance. There were no citizens present and no representation from the press.

Will Groves, Jr. made a motion to approve the consent agenda including December 3, 2014 Minutes, Fund Transfer Resolution #2014-16, Temporary Loan Resolution #2014-17 from Trash to Recycling, Fund Appropriation Transfer Resolution #2014-18 and vouchers. Richard Warner seconded the motion. All voted to approve.

2015 Wages were discussed. The Town Council discussed 2% for the Town Council, 4% for department heads, and 2-3% for full time employees.

Will Groves, Jr. made a motion to approve Ordinance #2014-11 North Liberty Town Council 2015 Wages with a 2% annual salary increase Town Council President \$4,658.00 and Town Council Members \$4,154.00. Richard Warner seconded the motion. All voted to approve.

Will Groves, Jr. made a motion to approve Ordinance #2014-12 North Liberty Park Board 2015 Wages Park Board President \$490.00 annually, Board Members \$450.00 annually, and Park Maintenance \$750.00 annually. Richard Warner seconded the motion. All voted to approve.

Will Groves, Jr. made a motion to approve Ordinance #2014-13 North Liberty Police Department 2015 Wages Town Marshal \$23.50 per hour, Deputy Marshal 1st Class \$17.63-\$21.60 per hour, all other wages remained at the 2014 rate. Richard Warner seconded the motion. All voted to approve.

Will Groves, Jr. made a motion to approve Ordinance #2014-14 North Liberty Utilities 2015 Wages Superintendent of Utilities and Streets \$2084.16 bi-weekly, Class B employees \$18.49-\$22.49 per hour plus certification pay. Richard Warner seconded the motion. All voted to approve.

Will Groves, Jr. made a motion to approve Ordinance #2014-15 North Liberty Clerk's Office 2015 Wages Clerk-Treasurer \$2084.16 bi-weekly and \$19.42 per hour for Deputy-Clerk. Richard Warner seconded the motion. All voted to approve.

The Town Council discussed No Parking along South Street.

NIPSCO Rate Agreement for Oak Street Kift Station was executed.

2015 Humane Society of St. Joseph County was executed.

With no further business before the North Liberty Town Council, Will Groves, Jr. made a motion to adjourn at 5:35. Richard Warner seconded the motion. The vote was unanimous.
