

## **North Liberty Town Council Minutes – June 18, 2014**

The regularly scheduled meeting of the North Liberty Town Council was held at the North Liberty Community Building. Gerry Brown called the meeting to order at 7:01 P.M.

Will Groves, Jr., Brett Voreis and Matthew Peterson, Council Members, were in attendance. Council Member Richard Warner was not in attendance. Attorney Peddycord, Utilities Manager Skip Davidson, Town Marshal Michael Sawdon and Vicki Kitchen, Clerk-Treasurer were at two code enforcement hearings in the other end of the building. There were no citizens in attendance. There was no representation from the press.

Matthew Peterson made a motion to approve the vouchers. Brett Voreis seconded the motion. All voted to approve.

The newest version of Tree Ordinance #2014-03 was tabled. Vicki Kitchen will e-mail the ordinance to council members for passage at the July meeting.

The town council requested Vicki Kitchen to e-mail 1<sup>st</sup> Source Bank regarding the status of the Potato Creek Grill.

The town council has been made aware of a property with ducks and chickens in Town. A code enforcement letter to the property owner is to be sent with a copy to Attorney Peddycord.

Brett Voreis made a motion to have the town council sign the INDOT permit for the closure of State Road 23 for the 4<sup>th</sup> of July Parade. Matthew Peterson seconded the motion. All voted to approve.

Will Groves made a motion to approve Ordinance #2014-04 AN ORDINANCE TO AMEND TITLE 3, ARTICLE 2 MOTOR VEHICLES BY SPECIFICALLY AMENDING: CHAPTER 3 PARKING OF MOTOR VEHICLES, SECTION 5 PROHIBITION OF PARKING OF THE NORTH LIBERTY TOWN CODE BY AMENDING SAID SECTION 5 TO PROHIBIT THE PARKING OF A MOTOR VEHICLES ON EITHER SIDE OF THE 100 BLOCK OF SHAMROCK DRIVE AND TO ESTABLISH A PENALTY FOR THE VIOLATION THEREOF; CHAPTER 5 TRAFFICE VIOLATIONS SECTION 5 PREFERENTIAL STREETS BY ADDING AND DESIGNATING SHAMROCK DRIVE AS A [PREFERENTIAL STREET AT ITS INTERSECTION WITH SHENEMAN DRIVE. Brett Voreis seconded the motion. All voted to approve.

Brett Voreis seconded the motion. All in favor none opposed.

Flags for the new flag poles were discussed. Vicki Kitchen is to obtain a price on a Town flag with a shamrock with North Liberty over the shamrock and the year of incorporation below.

With no further business before the North Liberty Town Council, Matthew Peterson made a motion to adjourn at 7:20. Will Groves, Jr. seconded the motion. The vote was unanimous.
